HELP US PROTECT YOUR ACCOUNT: CARD FRAUD

Debit card & Credit card fraud involves the unauthorized use of another person's card information to make purchases from their account or access their funds. Card fraud occurs in lots of ways including phone scams, email scams, data breaches, and card or mail theft.

How is this fraud occuring? Most of the fraud occurs through phone calls claiming to be from the credit union. The fraudsters then convince you to give them your card number, pin number, expiration dates and or cvv code from the back of the card. HCP will never ask you for this information. We know them already.

If you get a call like this, hang up!! Call the credit union directly at 765-962-3172. If it is after hours, leave a message and we will get back to you as soon as possible.

THERE ARE SOME THINGS YOU CAN DO TO FURTHER PROTECT YOURSELF:

- Be Careful With Your Card Information
- Never give your account information to anyone over the phone unless you initiated the call to a company you know to be reputable.
- If fraud does occur, report it quickly and minimize damage.

Remote Control Cards: Instantly secure your debit card or credit card.

Online Banking and our Mobile app have this security feature built-in. On the main menu, look for "Remote Control Cards" to control your card with one tap.



Account Alerts: Set up email or mobile push notifications.

Login to Online Banking or our Mobile App and select NOTIFICATIONS to manage the types and frequency of your alerts.
