48th Annual Meeting & 2023 Election Information

The 48th Annual Meeting of Health Care Professionals Federal Credit Union will be held at 6:30 p.m. on Wednesday September 27th, 2023 in the lobby of the Richmond Branch, 1810 Williamsburg Pike, Richmond, IN 47374. Doors open at 6:30 p.m. with the business meeting to begin at 7:00 p.m. The purpose of the Annual Meeting is to receive and act upon the reports of the officers of the credit union, to announce the results of the election of directors, and to transact such other business as may properly come before this meeting.

HOW TO ATTEND:

ELECTION:

In accordance with the credit union's bylaws, the nominating committee has nominated one individual for one (1) vacancy on the board of directors, to serve a three-year term and they have agreed to serve if elected:

Thomas Herrman: Thomas retired in 2009 from Reid Hospital and is very involved in community activities. He currently volunteers at the Wayne County Cardinal Greenway, Hayes Arboretum, and Boys & Girls Club of Wayne County. Thomas has also volunteered for 20+ years at HCPFCU, currently serving as Board Chairman.

The elections will not be conducted by ballot and there will be no nominations from the floor when there is only one nomination for each position to be filled. Nominations for vacancies may also be made by petition by a minimum of 20 members and a maximum of 500 members. Each nominee by petition must submit a statement of qualifications and biographical data to the attention of the nominating committee appointed by the board of directors. A signed certificate from the nominee(s) stating that they are agreeable to nomination and will serve if elected is also required. SPOT THE RED FLAGS OF FAKE TEXT MESSAGES:

Don't trust unsolicited messages.

If you receive a suspicious text message, do not reply or click on any links. Instead, contact the company directly to verify the message.

Watch out for suspicious links.

Scam text messages often contain links that can download malware onto your device or lead you to a fake website where scammers can steal your personal information.

Know that a personalized message doesn't make the sender trustworthy.

Scammers may have your personal information and use it to make their messages seem more legitimate. Contact the business directly.

Look for spelling and grammar errors.

If you see strange phrasing or word choices along with errors, it's likely a scam.

If a website looks real, check again.

Scammers can create fake websites that look like the real thing, so always check the URL before entering your personal information.

Look up phone numbers before you call.

Be wary of calls from unknown numbers, and never give out personal information over the phone unless you are sure the caller is legitimate.

If you spot a scam text, don't reply.

If a text message seems suspicious, don't reply. Block the number and erase the message.
